

## Canterbury Hockey Association Terms and Conditions

1. **Accuracy:** The details set out in this Registration Form are true and correct. If they change, I acknowledge that I am required to notify the Canterbury Hockey Association in writing as soon as possible after they occur. If the details provided are not true or are misleading, I acknowledge my membership may be terminated at the discretion of the Canterbury Hockey Association.
2. **Bound by Rules:** I will be bound by the constitutions, regulations, policies, manuals, guidelines, and reasonable directions of the Canterbury Hockey Association. I agree to abide by the Canterbury Hockey Association's Code of Conduct.
3. **Accept Risk of Canterbury Hockey Association:** I have voluntarily accepted and assumed the inherent risk of loss, danger, and injury in the Canterbury Hockey Association.
4. **No liability:** I agree that it is a term of entry to any Canterbury Hockey Association Event or a term of participation in any Canterbury Hockey Association sanctioned activity in New Zealand that,
  - a. Canterbury Hockey Association, its board of directors, officers, contractors, employees, volunteers or agents, officers, managers, coaches (collectively called "CHA").
  - b. Affiliated Club Members, their committee members, volunteers, paid employees, and coaches; and
  - c. The sponsors and suppliers to any CHA and Affiliated Club Members event including their directors, officers, employees, contractors, or agents (collectively called "The Sponsors")

are all absolved from all liability however arising from any loss, injury, or damage to me, however caused (whether fatal or otherwise), during my participation in any such event or activity, and whether or not that injury or damage is due to any negligent act, breach of duty, default and/or omission on the part of CHA, Affiliated Club Members, or The Sponsors.

5. **Indemnity:** In consideration of Canterbury Hockey Association allowing me to enter any event or participate in any Canterbury Hockey Association and Affiliated Club Members sanctioned activity, I hereby:
  - a. Release and forever discharge Canterbury Hockey Association and Affiliated Club Members from all actions, suits, proceedings, claims, demands, losses, damages, costs, expenses however arising that I may have, or may have had, but for this release arising from or in connection with my participation in any Canterbury Hockey Association or Affiliated Club Member sanctioned events/activities.
  - b. Indemnify Canterbury Hockey Association and their Affiliated Club Members in respect of any actions, suits, proceedings, claims, demands, losses, damages, costs, expenses and penalties however arising as a result of or in connection with any Canterbury Hockey Association and Affiliated Club Members sanctioned event/activities and my participation in such event or activity whether caused or contributed to directly or indirectly by any act or omission on the part of Canterbury Hockey Association and its Affiliated Club Members.

6. **Medical Declaration:** I am medically and physically fit and do not suffer from any injury, disease, or condition, either physical or mental, that would affect my ability to safely participate in any authorised or recognised activities of the Canterbury Hockey Association and Affiliated Club Members. If I am unsure about this declaration or suffer from such a condition, I have either listed it on this form or I am aware that I must bring it to the attention of the Canterbury Hockey Association and Affiliated Club Members and will do so within five working days of making this declaration.

- 7. Photos and Images:** I agree to being photographed, filmed, and videoed or to have my image recorded in any way, including Drone filming, in the period from the commencement of registration until after the award ceremony for any event or during the time of my participation in the activity. I agree to Canterbury Hockey Association and Affiliated Club Members using any such imagery in connection with the future promotion of Hockey, the event or other events and activities. I understand that I am entitled to request access to such images and to receive copies of them at my cost.
- 8. Privacy:** By completing any Canterbury Hockey Association and Affiliated Club Members event entry forms and activity participation forms, I am providing the organisers with personal information about myself. This information will be collected and held by Canterbury Hockey Association and Affiliated Club Members and may be used by its sponsors, contractors and agents associated with the event or activity for the purposes of:
- a. Administering my entry in the events and participation in the activities.
  - b. Providing me with medical treatment if I am injured or suffer a medical event during my participation.
  - c. Promoting the events or activity, including in forming the media of the names and details of the competitors.
  - d. Any other purpose I agree to in writing.
- 9. Use, Security and Access:** I understand that my personal information will only be used for the purposes listed in paragraph 8 and in accordance with the Canterbury Hockey Association Regulations, and that:
- a. My personal information will be held securely;
  - b. I will have access to my personal information under the Privacy Act 2020 or any subsequent replacement of this legislation;
  - c. My personal information will be corrected upon request.
- 10. Interpretation:** In this document unless the context indicates otherwise:
- a. Every reference to “I” and “my” in this document includes the player and the parent/guardian/caregiver of the player (if applicable);
  - b. “Canterbury Hockey Association” has the same definition as that provided in the Constitution;
  - c. “Affiliated Club Member” has the same definition as that provided in the Constitution;
  - d. “Constitution” means the Constitution of Canterbury Hockey Association dated 28<sup>th</sup> February 2018.
